**ELECTRONIC CLUB COMMUNICATION OPTIONS TO YOU**

**Alert Notification System**

CCE has an **Alert System** that sends out e-mails and SMS text messages to inform members of the occurrences or details on events that may not have been covered in the monthly *Airhorn* newsletter. There are two categories of e-mails that are sent out: Alerts Only and both Alerts and Notices. Selecting any of these options gives CCE permission to send e-mails and SMS messages (provider charges may apply). E-Mail addresses are required for Alerts/Notices.

**Alerts Only** are important messages, like a last minute change in a meeting venue, cancellation of an event or the passing of a member or one of their family.

**E-Mailed Alerts and Notices** include all Alerts plus messages of lesser importance, like a reminder of a CCE sponsored event or something else of importance to the club.
